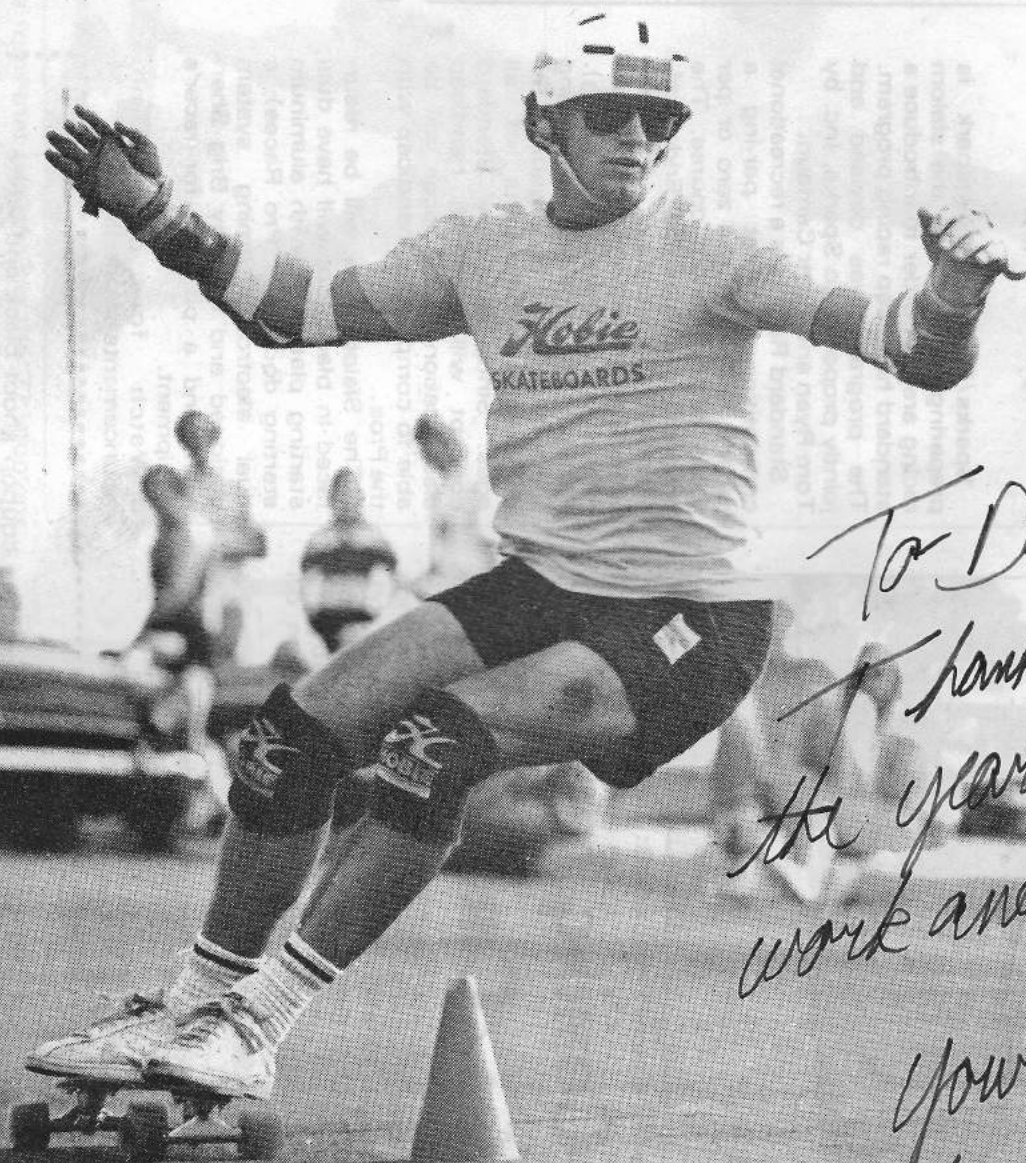

## PLANS COMING FOR '78 A.R.A. CIRCUIT

The 1978 Professional Race Circuit is now being scheduled for the coming summer season. Stops on the tour will be confirmed in the forthcoming months. A tentative schedule shows competitions in Colorado, Texas and California. The Circuit will feature Downhill, Giant Slalom and Dual Slalom. Pros will compete for a cash purse (undisclosed at present time). An accumulative point system will

rank the Professional standings and the 1978 Tour Champion. Another point system will be established to tabulate Manufacturer equipment won on by the Pros.

## NEWS RELEASE

Sparks/Carlsbad Skatepark is preparing to resurface the slalom racing area, in order to introduce a standard handicap racing program. The program was devised and jointly proposed to Sparks, Inc. by Tom Ryan and Peter Camaun.

Standard Racing is a recreational competition concept paring a racer's time with the zero or par value of the slalom course. The program will operate Friday afternoon, Saturday, Sunday, tentatively scheduled to begin late February (weather permitting). Recreational and Industrial racing Leagues will also be organized for competition enthusiasts of all ages. Since the new Standard concept will establish handicap classifications, any racer will be able to compare his handicap with the Pros.

The Slalom area will be resurfaced in black top, will have dual starting platforms with aluminum starting doors (for Pro Races), a dual electronic timing system designed and built by Brig Sherman, and a pit area for racer's equipment.

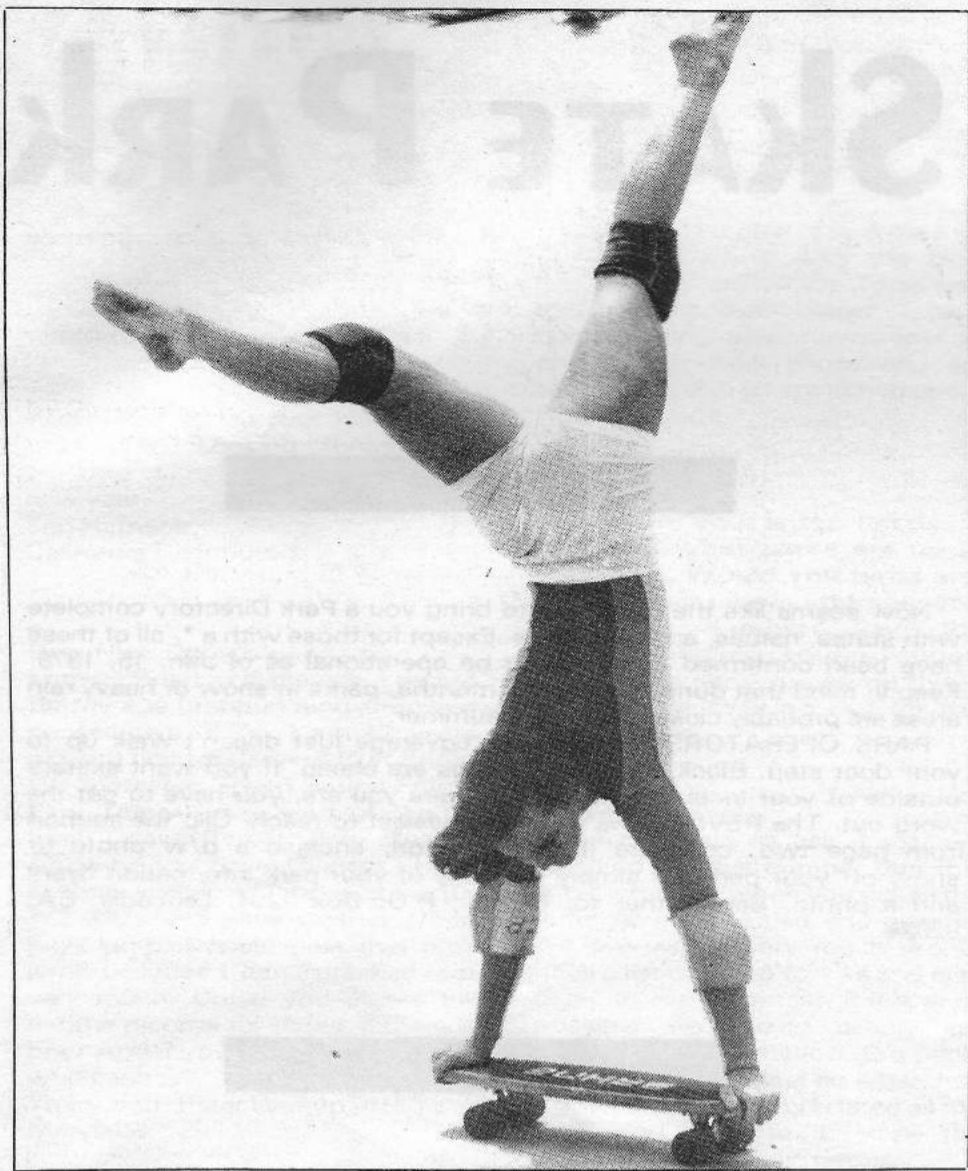

## SKAbo DIRECTS CBS CHALLENGE OF THE SEXES

In November, 1977, SKAbo developed, designed and produced two skateboard segments for CBS TV's "Challenge of the Sexes." The first segment will feature Women's Champion Record Holder, ROBIN LOGAN, versus Double World Record Holder, ERNIE MARTIN (Readers Digest, Guinness Book of World Records), both under contract to SKAbo.

The second segment will feature World Freestyle Champion, ELLEN BERRYMAN, versus Men's Eastern United States Freestyle Champion, HUCK ANDRESS, who is under contract to SKAbo.

Color commentator for the production was Dave Dash, Publisher of Skateboarder magazine. The superb judging was

performed by Di Dootson, Editor of National Skateboard Review, Brian Gillogly, Associate Editor of Skateboarder magazine, Industry Spokesman, Denis Schufeldt of Logan Earth Ski, and Bob Mohr, reigning Men's World Champion in Freestyle.

The competition, titled the SKAbo Pentathlon, was structured closely to the modern Olympic Decathlon. The best overall performance was judged by the individual competitors' skills in each event. Standards were set according to known records, and competitors competed, not only against each other, but also against themselves and world records.

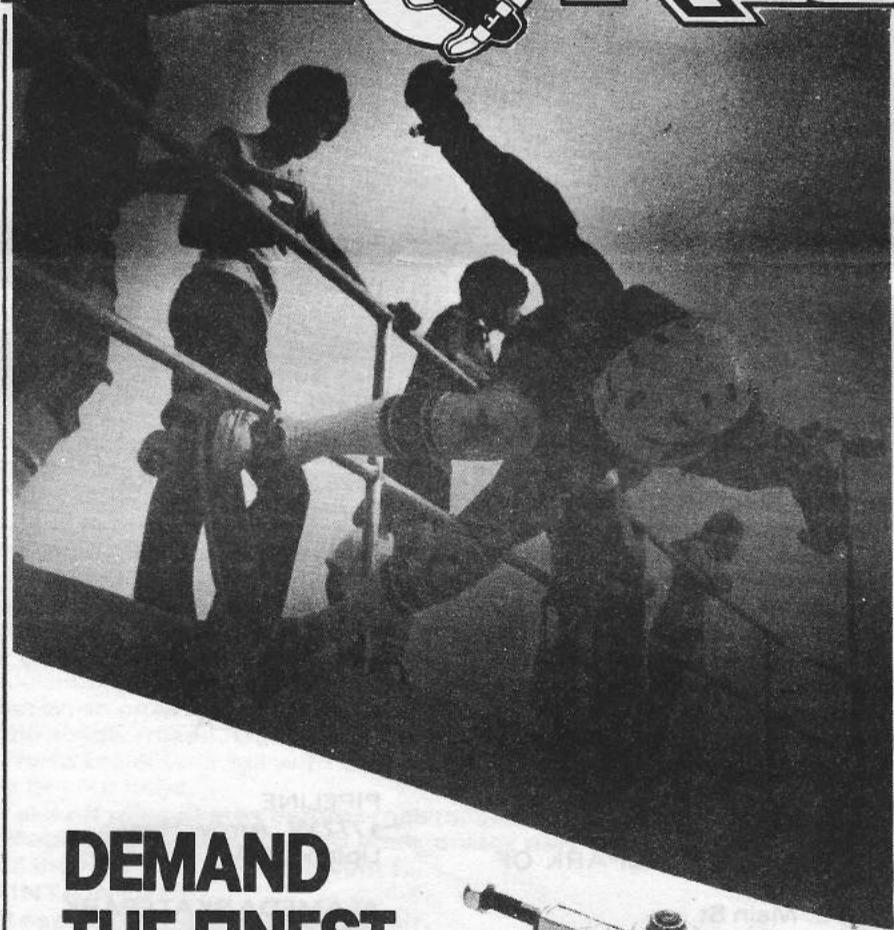

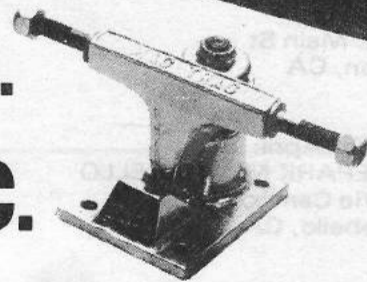

# HESTER OPEN

When promoters don't do it the way you like, you have to do it yourself. This coverage of Hesters Open Challenge 500 could almost be in the "Skater's Opinion" department. Henry sponsored this professional Giant Slalom and Masters race himself in order to give serious racers a good giant slalom race that would be relaxed, fun, and profitable. He feels strongly that unless manufacturers support the sport it will phase out like the first time in the Sixties. He feels that sponsoring good (!) competition is probably the easiest way to do that. This event is being covered by the REVIEW, Skateboarder, Wild World of Skateboarding, and Skateboard World. There was no network TV, but then again they are not the only answer to the sports' problems.

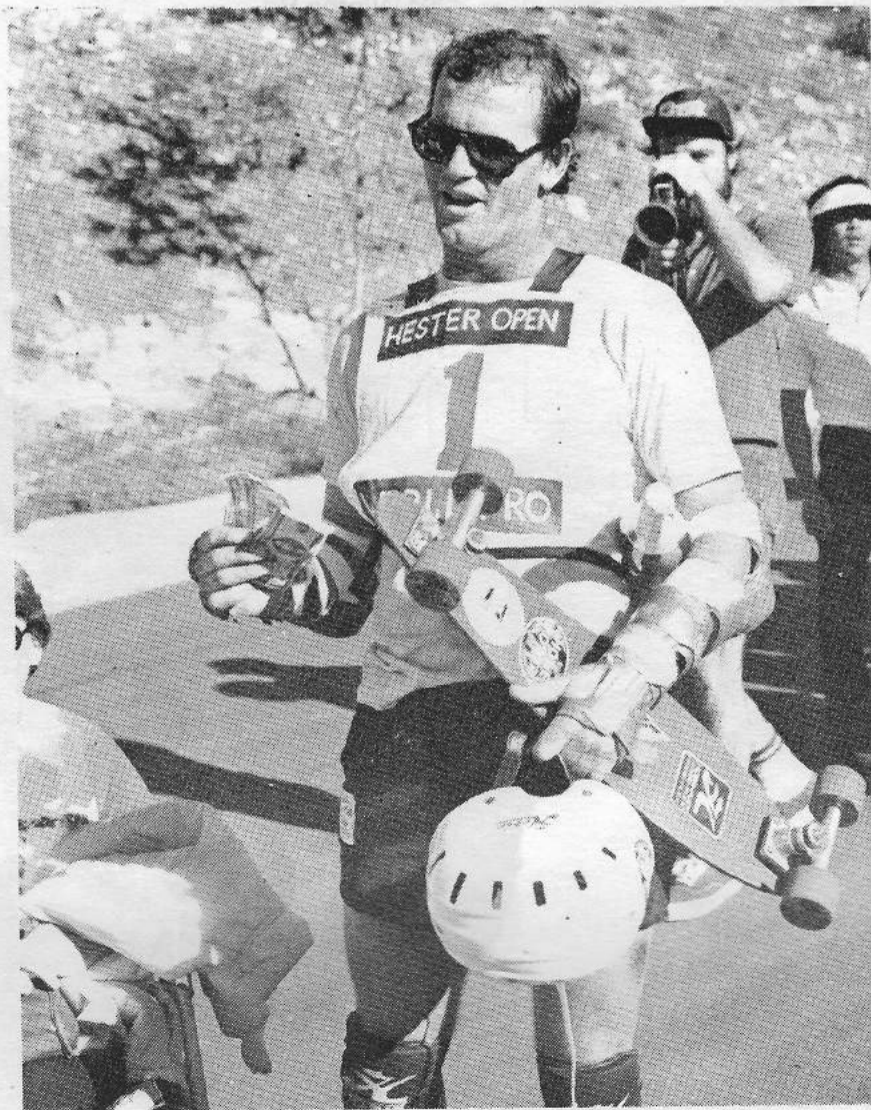
He wanted a La Costa style race and so it was. He set a wide, long, fast, super cranking course (check body angles in the photos). He told racers they wouldn't like it at first. It was one of those courses that you have to ride six or seven times before you get into it. He was right. Complaints started soon after the green-X course was down in November. Contenders mumbled about Henry's "slow, typical Hester course"; that "only Henry likes those kind." By the end of race day, Jan. 8, they loved it. Just because it isn't easy, is something new, doesn't mean you can't get into it.

Registration, if you can call it that, was also in the La Costa style: sign up and pay your money (\$25 for Pros, \$10 for Masters) when you get there.

The turnout could have been a photo from '75. Besides the regular Pros, and the young Pros, there were some Classic Pros: TORGER JOHNSON came over from Hawaii for a little Colorado snow and Henry's race, BRUCE LOGAN entered the race and made a strong showing on the hill with his nose-wheelies and racing, STEVE SCHISLER, one of the original Turner SummerSki boys, came to race. One spectator noticed, "if you count all the racers hobbling along the sidelines, there is everybody here that ever raced" . . . and then some new ones. A rampant amount of injuries had eliminated some expected racers. DENNIS SCHUFELDT was still recovering from an auto accident; JOHN KRISIK had a broken collarbone; Even Henry had torqued his ankle on his own course.

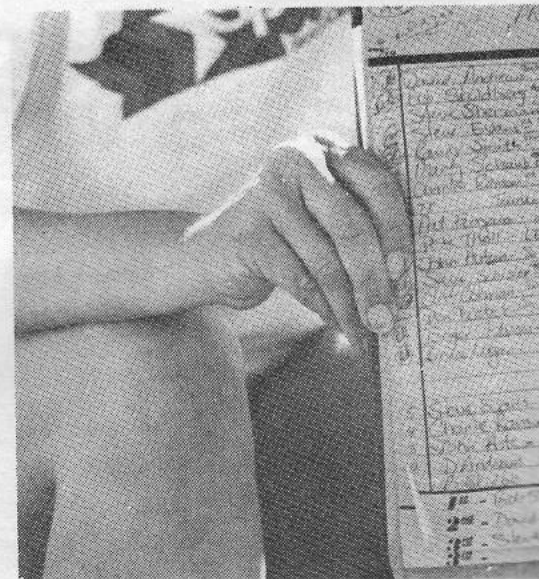
The stage had been set. Riders had been working out since the course was set three months prior. Out of town racers had been to Box Canyon a few times to practice. Local were riding it hard. T.R. (Tom Ryan) went for sessions with PETER CAMANN every morning and evening for two weeks before the race. DAVID ANDREWS had been keeping himself a secret, but rumors had it that his time had come and he was the man to beat.

Brigg Sherman was there to time the race. A "veteran" of Long Beach and Akron crisis, Brigg has been overshadowed by Chrondek and other professional timing companies. But he shone at La Costa. A full day of good times. If only new racers and the crowd would learn to stay out of the timing lights at the bottom of the hill!

# CHALLENGE 500

The Masters raced first. As Henry had said, first man was in the gate at 10 a.m. A small field, the four runs each went quickly. DON BOSTICK, Master's winner from the November race was clearly the leader. He even passed on his third and fourth runs to save himself for the finals. CLIFF COLEMAN, 2nd place winner from the November race was on show again. He advanced to the finals in second place. PETER CAMANN, the A.R.A. (Another Roadside Attraction) circuit director from Colorado, took a while getting the pulse of the course but got into it in his last two trial runs and advanced to the finals in third. PHIL BOSTROM is a new rider to skateboarding. His experience in water ski competition is of obvious help in his first skateboard slalom race. BROOKS THOMAS entered the race on a Ski Skate (see photo) An eye catching skateboard of sorts, he was especially flowing through the cones. JEFF JUNKINS, always a serious racer, was on the line up once again.

The three final runs were over even quicker. No upsets occurred and the three finalists finished in the same order they entered: Bostick, (Santa Cruz) first with 24.242 sec; Coleman (Santa Cruz) second with 25.038 sec; and Camann (Another Roadside Attraction) third with 26.343.

The Pros were eager to start. The recorder, Di Dootson, was barraged with entries as soon as the Masters were over. Henry gave them another hour of practice before the race actually started. Jeff Junkins was the Starter. An experienced Starter from both Long Beach contests, Jeffrey is clearly the only man for the job. "He doesn't take any ----"; "he keeps us in line." Those are racers talking and anybody drawing that kind of respect is the only man for the job.

David Andrews and Bob Skoldberg were the first two out of the line up and were early pace setters. Their first run of 22.9 (D.A.) and 22.8 (Skoldberg) were the best times all the way through the sixteen entries' four runs until Bob's fourth run improved his first time by .1 second. With only five racers advancing to the finals, the cut off time turned out to be STEVE EVANS' 23.290. Just missing the advance were STEVE SHERMAN and MARTY SCHAUB — a pair of young pros who cut their racing teeth on La Costa hills.

Skoldberg advanced as first, Andrews second, JOHN HUTSON in third, CHARLIE RANSOM fourth, and STEVE EVANS in fifth. Skoldberg still held an easy (?) first place. The only upset in the finals was Steve Evans' burst into third place — dropping Hutson to fourth and Ransom to fifth.

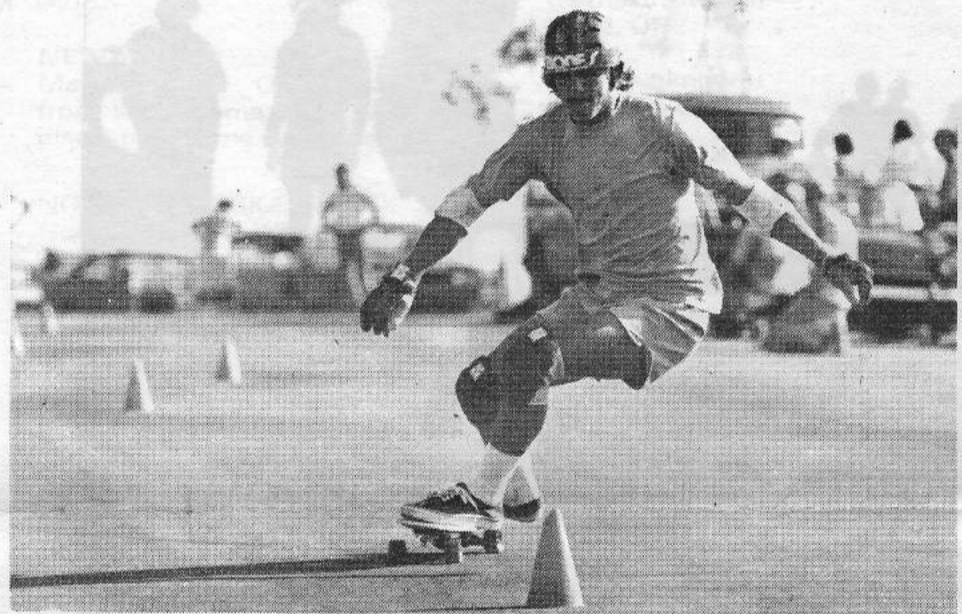

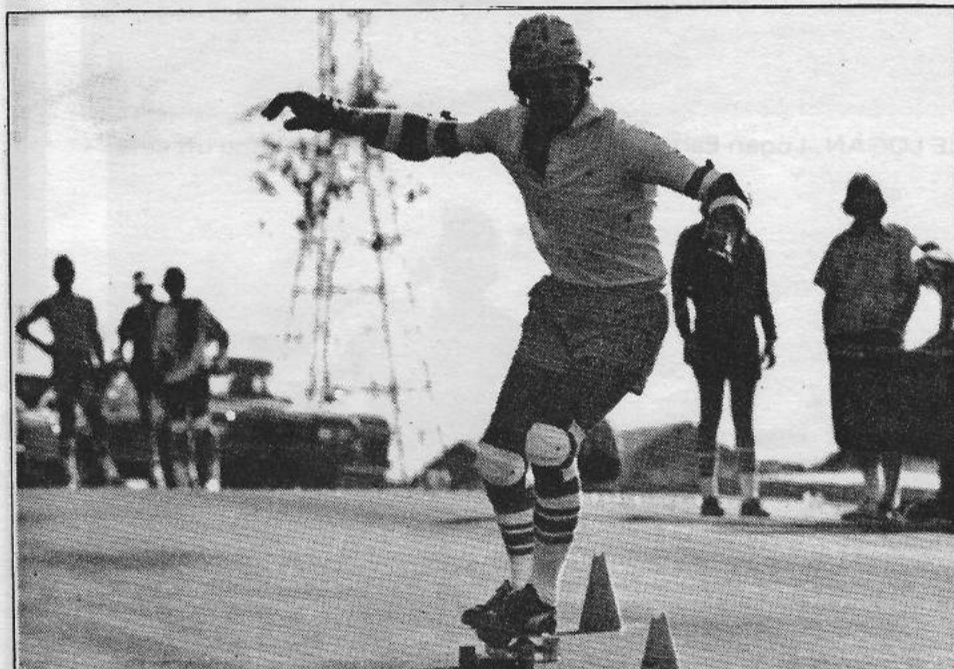

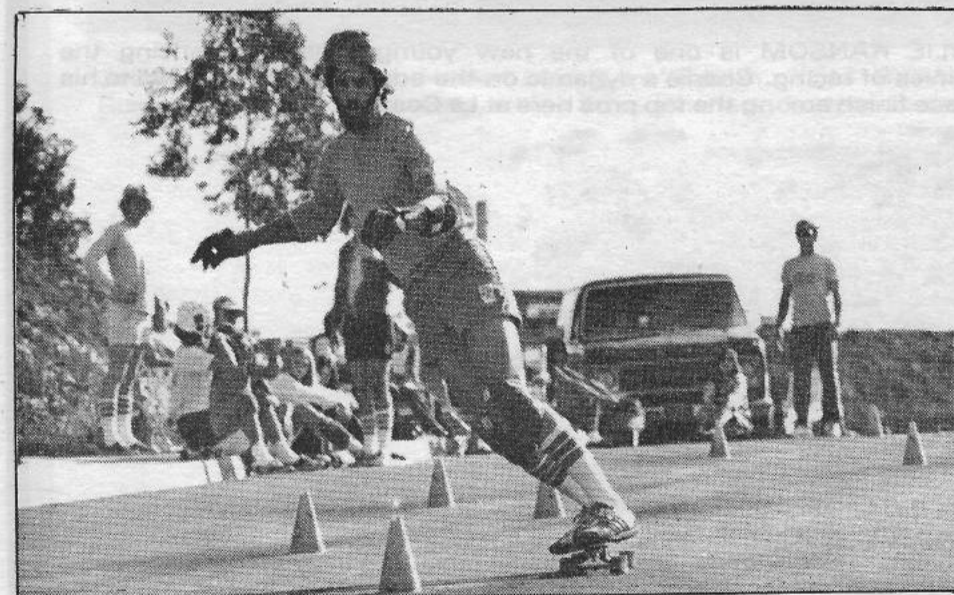




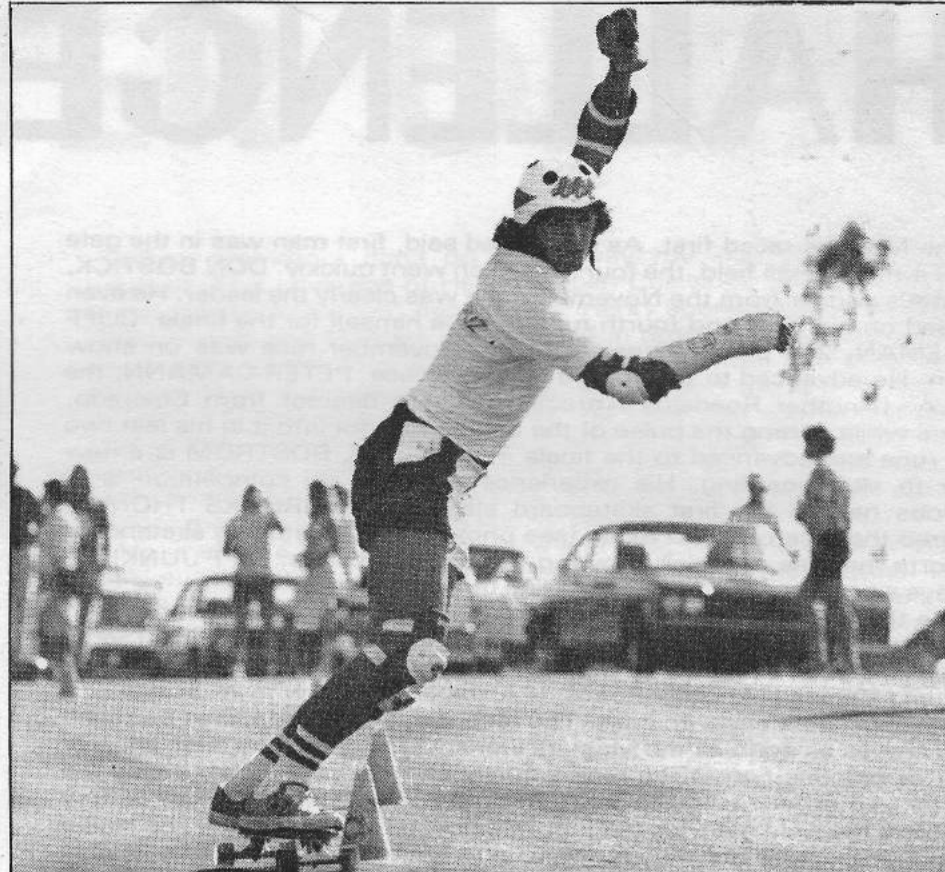

Dear Mr. Dootson:  
We are pleased to advise you that PHILADELPHIA SKATEBOARD PARK (PSP), a new concrete indoor skateboard park is now under construction in Philadelphia, Pennsylvania. The park will be located at Penn and Pratt Streets, in the northeast section of Philadelphia, with opening expected in late February 1978.

The goal of PSP is to provide a safety oriented skateboarding facility for the thousands of skateboarders in the heavily populated Delaware Valley, of which the city of Philadelphia is the focal point. In trying to accomplish this goal, we have selected a location which is easily accessible by public transportation as well as by automobile. Our facility is located at one of the major public transit terminal points — the last stop of Philadelphia's High Speed Subway and Elevated Train System. By choosing this location, we feel that our facility will not only be unique because it will be the first indoor concrete park that I am aware of, but will also be unique because it can be reached by the urban skater through the use of public transportation.

The skating areas, as described in the enclosed literature, will provide skating areas for beginners and advanced areas which will be challenging for the most advanced. We intend to provide an arena where East Coast skateboarders can hone their skills as the California and Florida skateboarders have been able to do.

I have enclosed an artist's rendering of PSP, as well as other literature including copies of news articles about PSP which have appeared in various Philadelphia local newspapers.

PSP will require all skateboarders to wear safety equipment (helmet, gloves, knee and elbow pads), and will require skaters to be members. Skating clinics will be held for novice skateboarders and various competitions will be held for the

## Report By '76 U.S. CONSUMER PRODUCT SAFETY COMMISSION

Many teens and children learn new skills on roller skates, ice skates, and skateboards but hard falls often accompany this learning experience. The U.S. Consumer Product Safety Commission estimates that approximately 104,000 persons receive hospital emergency room treatment each year for injuries associated with these products. Roller skates account for the majority of injuries, an estimated 59,835, and ice skates are involved in the second highest number of injuries, 33,410.

The following accident cases associated with roller skates, ice skates, and skateboards are taken from CPSC, (Consumer Product Safety Commission) investigation files:

"Thirteen year old Jim was roller skating on an indoor rink when another skater close in front of him stopped abruptly. Jim ran into the other skater, fell, and fractured his right wrist."

"Since the original wheels and mountings had broken on his skateboard, twelve year old Jon repaired and modified the skateboard. Unfortunately, the wood screws came loose, the wheels came off, and Jon fell, fracturing his left hand."

"Bruce's skates struck a rut in the ice. He fell and crashed into the wooden boards on the side of the rink, fracturing his right leg."

These cases illustrate some of the following causes of accidents associated with these products:

1. SKATING TOO CLOSE. Other skaters can stop abruptly in front of you or skate across your path and cause accidents.
2. PRODUCT STRUCTURAL PROBLEMS, such as improper modification and repairs, or excessively wobbly skateboards that can tip over easily.
3. POOR SKATEBOARDING OR SKATING SURFACE. Environmental hazards such as cracked or uneven cement sidewalks, rocks, tree branches, or other debris can cause tripping or skidding. Ice skaters can encounter ruts in the ice or grass and gravel on outdoor rinks.
4. OTHER CAUSES CAN INCLUDE THE "HUMAN FACTOR." a) inexperience with the skates, skateboards or with "trick" skating; b) horseplay and pushing; c) lack of attention; and d) misuse, such as going up and down steps with skates on.
5. SKATEBOARDING OR ROLLER SKATING IN TRAFFIC.

You can help minimize serious accidents by carefully selecting and maintaining roller skates, ice skates and skateboards by advising youngsters on safe usage. THE U.S. CONSUMER PRODUCT SAFETY COMMISSION OFFERS THE FOLLOWING SUGGESTIONS:

### SELECTION:

- Buy skates that fit well
- Carefully run your hand over metal parts (ice skate blades excepted) to check for sharp edges and points that can cut in case of a fall.
- Skateboards need to "wobble" to maneuver corners, but too much wobble causes instability. Choose a sturdy skateboard with only enough "play" to turn corners well.

Note: Skateboard riders under thirteen years of age may not have adequate muscular coordination to maintain balance and sufficient maturity to exercise judgement about types of maneuvers to attempt on the skateboard.

### USE:

- Learn to perform basic skating and skateboard maneuvers well before attempting more complicated or "trick" moves.
- Check the skating surfaces carefully before and while skating. For street skating or skateboard riding, avoid uneven or broken cement and branches and rocks in the skating path. On outdoor ice rinks and ponds, look out for patches of grass and rocks, in addition to ruts and thin ice.
- Caution children against roller skating or using a skateboard in the street or on crowded sidewalks or ice skating on outdoor ponds that may not be solidly frozen. Obey "No skating" signs on ponds.
- Try to break your fall with your hands and avoid hitting the flat of your back or your head.
- Take off roller skates before crossing streets.
- Beginning ice skaters with weak ankles may want to tape their ankles until they are stronger to prevent falls.

### MAINTAINENCE:

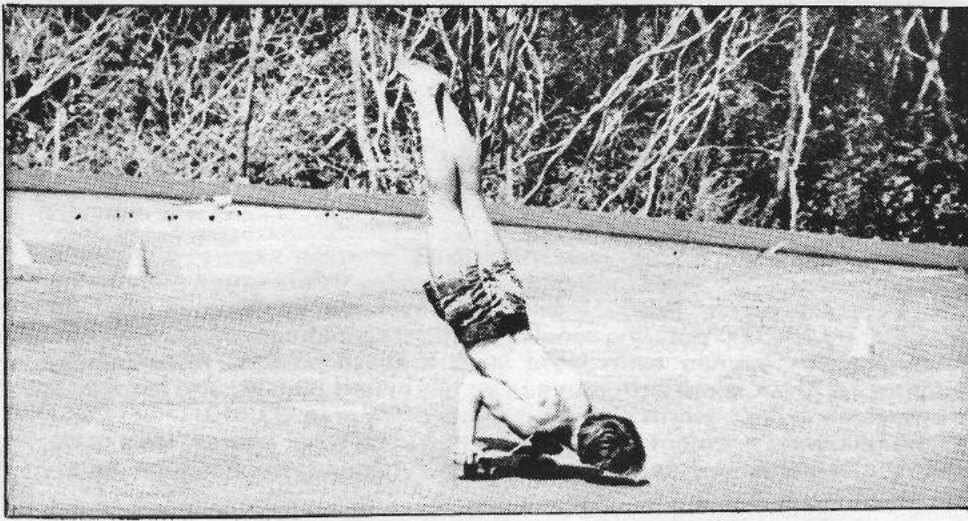
- Keep equipment in good repair.

## END OF 2ND SEASON

## FOR SO. NEW ENGLAND AREA

The Southern New England Eastern Surfing and Skateboard Association finished up its second successful competitive season on December 3, 1977. All this year's meets were run on a flat black tar lot in the Sprague Field Park in Narragansett, R.I. with cooperation from the Director of Recreation, Mr. Ralph Coppa, and with slalom cones donated by the Highway Department Director, Mr. Jerry Judge. Competition committee members voted to use the flat tar instead of local skateparks so as to give the majority of competitors an equal chance with no unfair advantage. Another major factor was the \$250.00 required to run one of our amateur meets at the area parks. Since our association is strictly non-profit, we could never put out that amount to run one of our meets.

International Skateboard Association rules were strictly enforced, except that each skater had two final two minute freestyle sessions to perform in, instead of one. This extended the length of the contest, but proved to be much more exciting to watch. Each contestant knew where he was in

the standings after each event, and if it was close, he would go for it to win. Hobie Skateboards of Dana Pt., Calif., donated over \$300.00 in amateur prizes for our contests, and all finalists received AAU style ribbons.

Meet Director, Cindy Pan, coordinated all scores and kept contestants notified throughout the heats. Only top skaters and surfers not entered in any events were used to judge the contestants. Each judge was paid for his services, to keep it as fair as possible. Skaters from as far away as Philadelphia, Pa. and Dana Pt., Calif. came. (Thanks to the National Skateboard Review.)

The NESAs held two clinics during the season. One was in Middletown, Ct. at the local YMCA. The Watershed Hobie Skateboard Team put on a demo and Director Pete Pan gave a safety talk. Another similar clinic was held at Yawgoo Valley Skatepark for 1st and 2nd graders at the West Kingston Elementary school. Hopefully, if there is no snow on the ground, the next big event up here will be our Mid-Winter Slalom Races, to be held on Feb. 25, 1978.

## '78 SIGNAL HILL RULES

### STAND-UP RULES:

- As a safety precaution, stand ups will be required to wear a surfboard type leash.
- Stand up means exactly that - no lying down. The only permissible points of contact are your feet (hands may be used for initial balance); No knee touching board, no foot straps, no prone positions.
- No weight belts on person or adulteration of skateboard during or after official weigh in.
- The skateboard must be a stock, flat surface. No handlebars, no fairings. Two standard trucks (no split axles), and four wheels only. (Specifications are: board weight - 25 lbs, max. length - 10 feet, width - 10 inches, length - 6 feet, axle width - 10 inches, wheelbase - 5 feet, wheel diameter - 4 inches)

- No pushing from team members or mechanical devices allowed.

### MODIFIED (speed car) RULES:

- As a safety precaution, modifieds will be required to have a drag chute and a braking system.
- Lean steering only. Two trucks and four wheels only. No split axles.
- Two team members may push racer. Push poles must detach or will result in a DQ (disqualification). No powered or mechanical devices allowed.
- Specifications:

board weight - 75 lbs  
max. length - 10 feet  
axle width - 12 inches  
wheel diameter - 4 inches

Further instructions will be sent to those qualifying entrants accepted by the U.S.S.A.

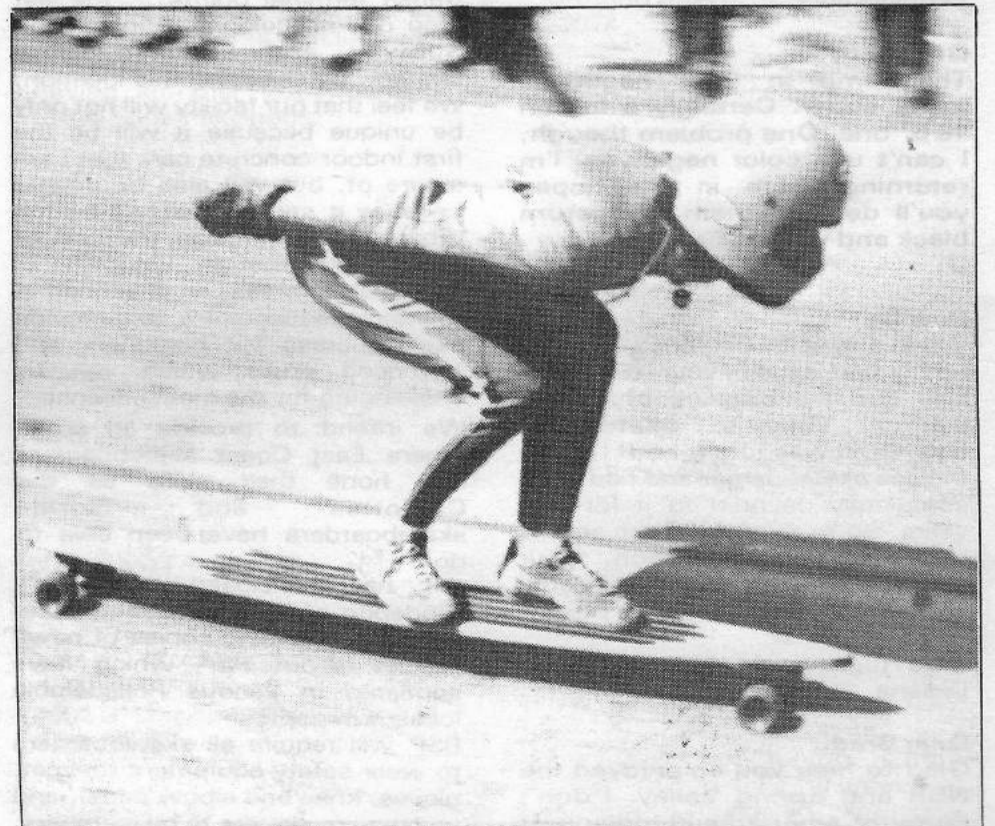

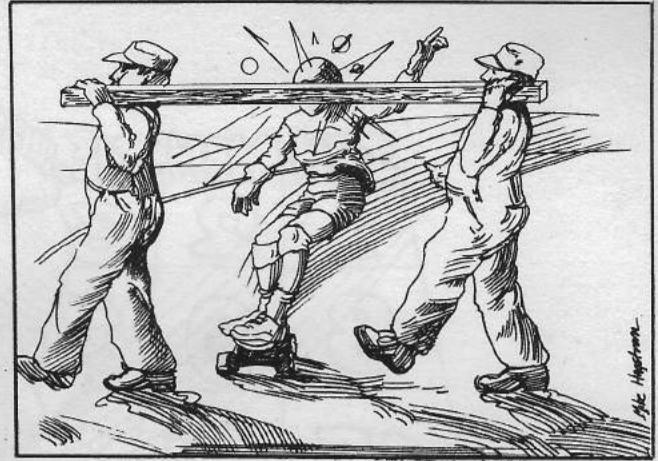
