The skateboard season is in full swing out here. Saturday, May 21 saw the first of three contests sponsored by Emilio's Ski and Surf shop. The contests are held at Eisenhower Park, East Meadow. The events are freestyle, slalom, and a pump race. There are three divisions for each event. The contest started at 1:00 with the freestyle event. Each contestant had two minutes to execute their routine. They were judged on a scale from one to twenty. Three entries from each category were selected to advance into the finals.

A high jump was set up instead of a slalom race since the ramp was not completed yet. However, it should be ready for the next contest. In the high jump each entry had three chances at any height they chose. Woody Woodstock won the event clearing 3ft. 9 in; followed by Bill DeGeorge who cleared 3ft 6 in.

After the high jump was the freestyle finals using the same rules as before. The next event was the most interesting - the pump race. Each contestant was allowed 20feet to push to; after that his feet could not touch the ground or he would suffer a DQ. The race was around a 220 yard circle. There were five heats; the winner of each heat advanced to the finals.

At the end of the contest trophies were awarded to the winners. The next two events will be held on June 11 and August 13.

"Another Roadside Attraction" has organized a competition circuit in Colorado. Prize money was awarded to qualifying professionals and merchandise was awarded to amateurs. A point system has been established that provides statistical information for ranking racers in this circuit. A separate point system will be used to determine leading amateurs in the Colorado tour. The positive projection is for Colorado racers on the tour to be recognized as legitimate competitors for invitational competitions on a national

The first was held in Boulder, Colorado, right down Main St. on May 14. Pro riders Tom Ryan, Bob Piercy, and Mike Williams flew in from California to compete here. Sixteen pro racers qualified with eight advancing to the money bracket. The race was won by Bob Piercy, who had to overcome a .072 second advantage held by Tom Ryan. On the second run, Piercy switched courses and beat Ryan by .106 seconds - a margin sufficient to win the 1st place money. Bouldeis Byran Kosick defeated Jim Whalen (of Boulder) in the consolation round to take third place.






TOMMY RYAN TO HEAD UP Sparks' Skatepatrol
