

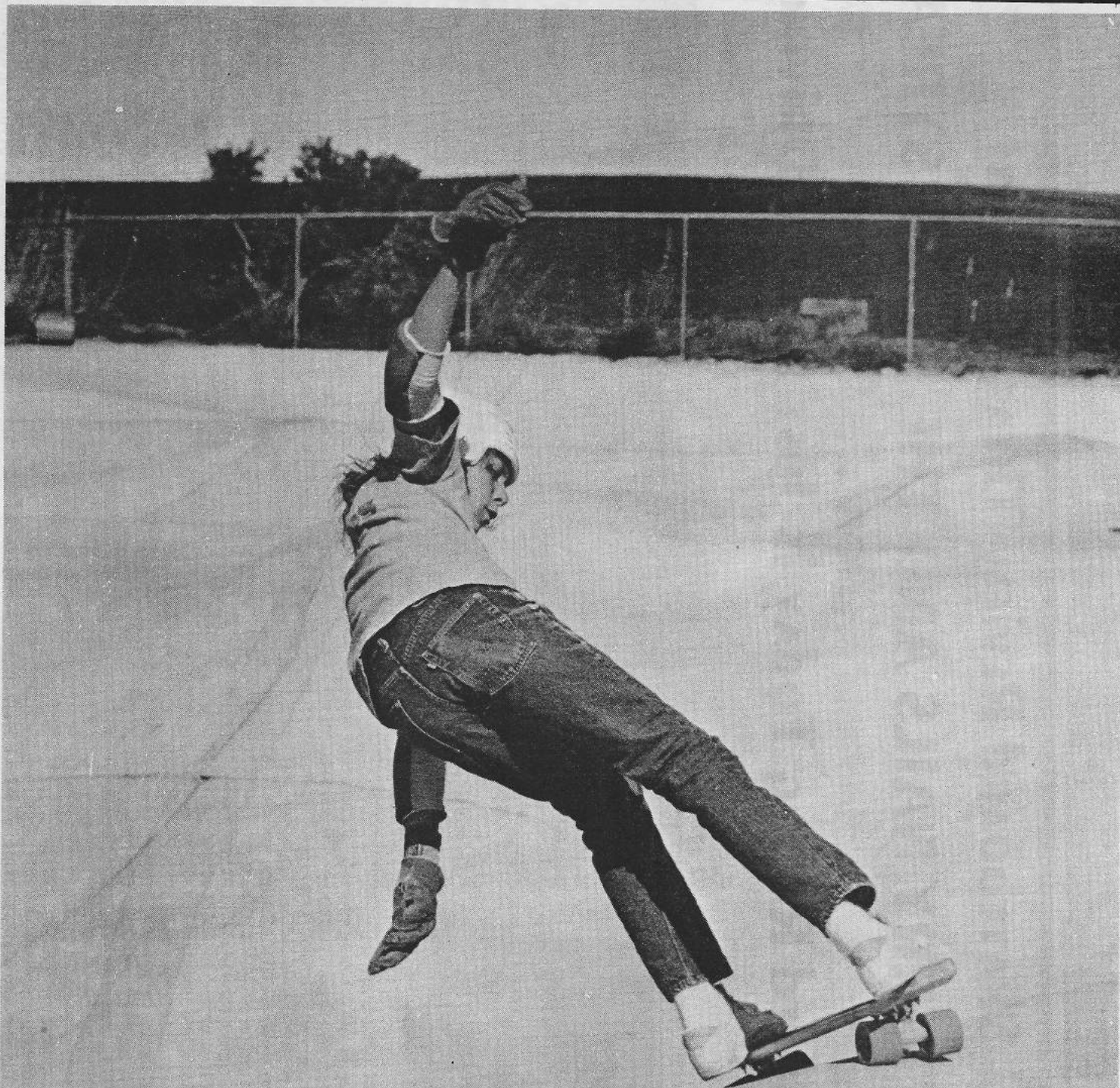

The set is identical to the 1976 version. The car that was skewered by the flying board last year is again parked in the same spot amid the black Signal Hill woodpecker oil pumps. The spectators hug the street, anticipating a fatal crash, the U.S.S.A. officials are intermittently attempting to coax the throng off the street, employing both the "sincere pleading" and "threatening-to-stop-the-race" techniques, as the Long Beach Police Department stops traffic and watches empathetically.

Terry Nails: Nails is a slight, San Francisco rock musician specializing in dobro-slide and bass in a band called "Killer Watt". Speedracing offers him that sweet release attainable only at speeds above 60 miles per hour. Signal Hill is a short, quick drop compared to those critical air-borne runs down the steep winding and cascading San Francisco streets.

He looks fast. Terry's got a contemporary counter-culture look about him. His shoulder-length, Rod-Stewart hair and extra-long fingernails, combined with an understated, laidback attitude all succeed in giving him an air of instant credibility.

Terry goes for it, heavily, and alone. He's been captured on film by Jon Malvino, shooting the elevator shaft drops of a radical San Francisco street, (a la Steve McQueen), and getting airborne, while negotiating sewer caps and other obstructions.

"What's happening in racing now is just Sunday driving compared to what we're in for," Terry comments. He further feels that 70-mph runs are just around the corner and 90 mph will eventually become status quo. His view of the future is progressive: a racer's union, a pro circuit, and big prize money for both Grand Prix and drag classes.

Today, March 20, 1977, Terry Nails is riding his sleek, coffin-like, fully-enclosed, silver stroker speed machine. As he prepares to take his first run, team mate Henry Hester waits for him at the end of the run-off area.

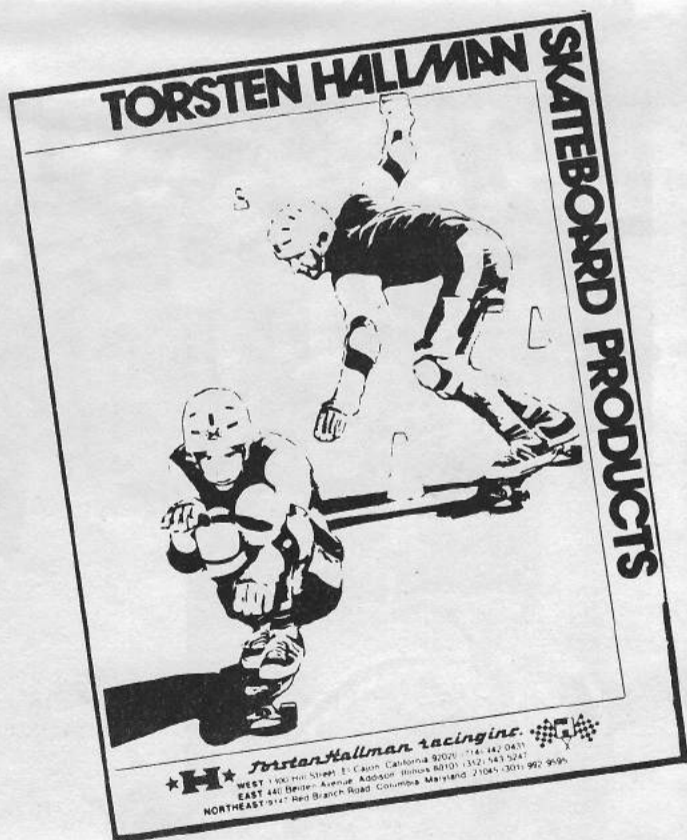

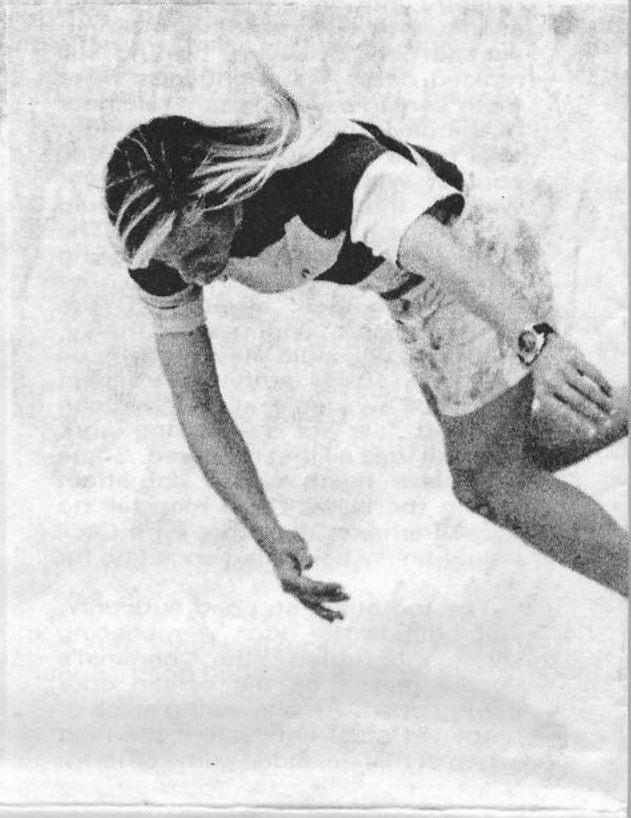

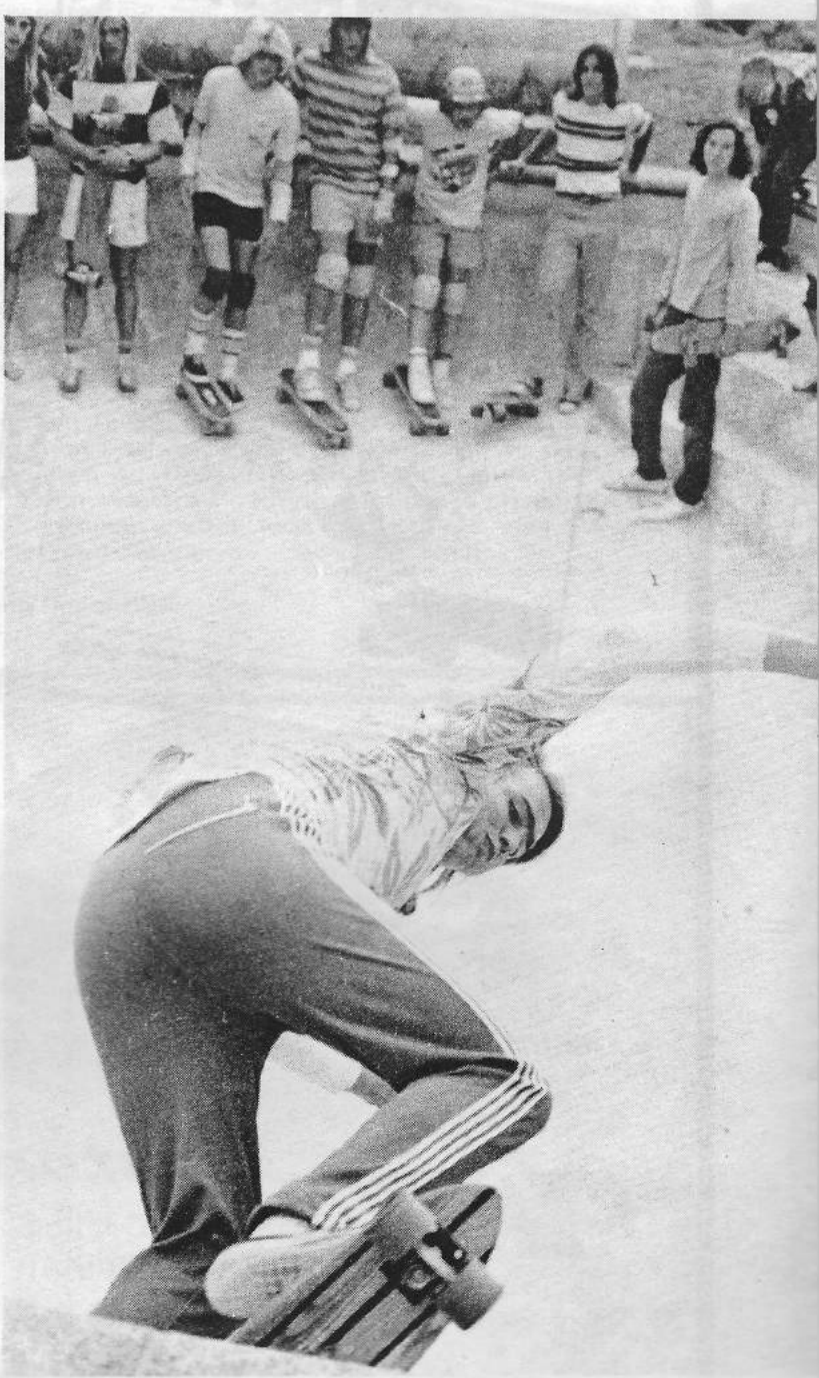


Sequential carve

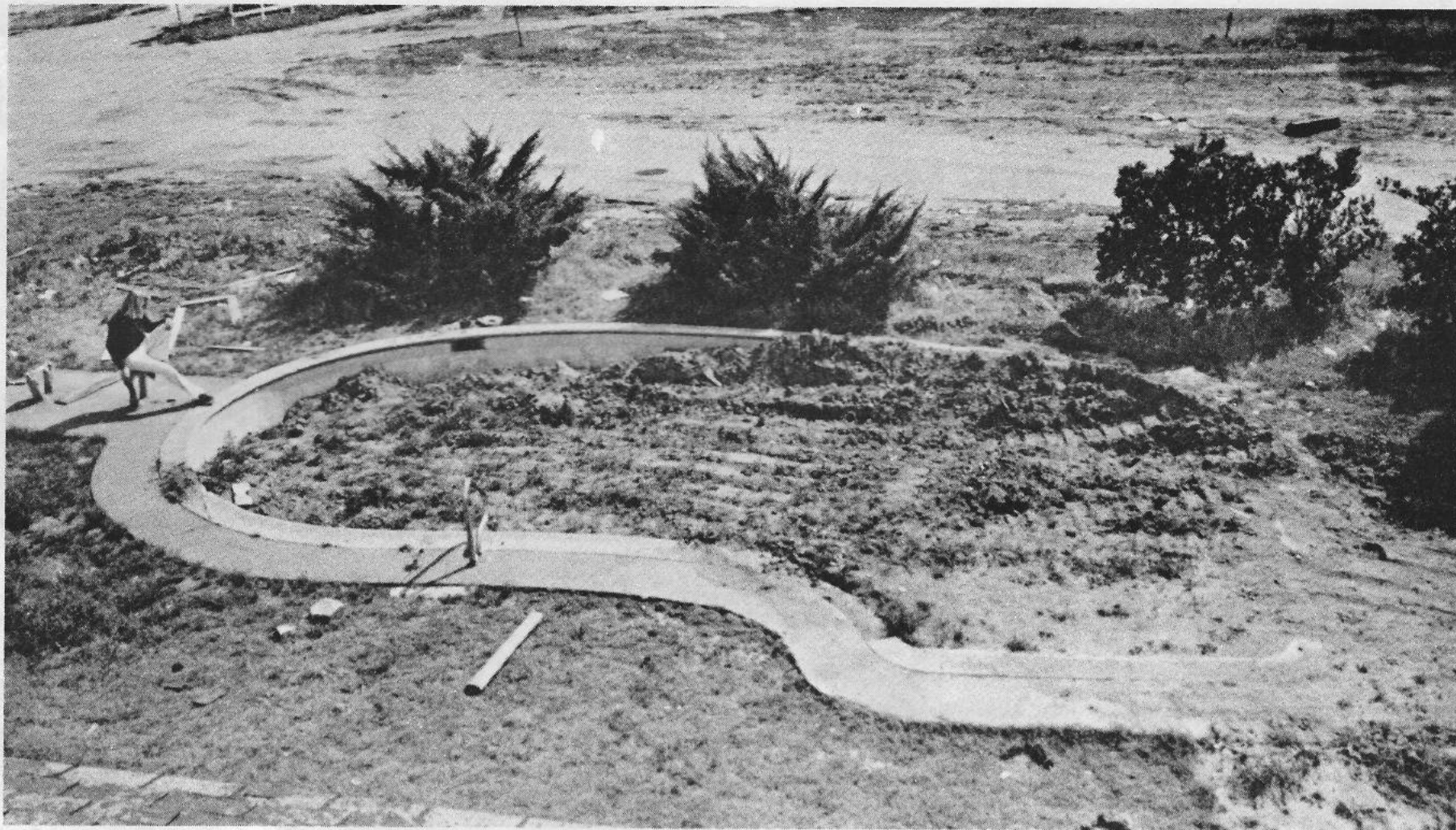

Informal activities include two local pools opening their facilities to skateboarders. Tiles are getting common and radical skaters more frequent. A state wide contest will be held in Santa Fe in early May. To date two parks are in the development stage in Albuquerque. Assuming no problems with zoning, the "Blue Sky Skateboard Park" will be constructed by Compo Construction and "Rollercross", a locally designed park, are slated for opening in early summer. Rumors are that a third park will be built in Santa Fe. New Mexico is rapidly assuming the role of skateboard center for the Southwest.

The Optimist Club sponsored and the University of New Mexico officiated the race on April 23. We saw some great racers and hope to get a good turnout at the Soap Box Derby Track on May 21st. Everyone wishing to compete must have a helmet, gloves, and pads. A signed competition release form available at Pop Tops, is good for one year.

As you all know there are several proposed skateboard parks for Albuquerque; however, the City Planning Department has received enough negative comment that they may not allow the building of these parks. PLEASE mail a card or letter NOW to Don Peterson, Zoning Examiner, P.O. Box 1293, Albuquerque, NM, 87103. Tell him that we need a safe area for skateboarding and that you will use the park.

## NEVADA CITY, CALIFORNIA

The Skateboard Associations of Nevada City and Grass Valley need a skateboard park. This fact sheet, prepared by an adult advisor to the associations, provides the basic details on what the teenagers in the associations are seeking and how they hope to get it.

The need for a skateboard park in the GV/NC area is well established by now, and well documented. We have on hand petitions supporting the objectives of the associations bearing nearly 500 signatures of local residents.

Association members will be approaching local government officials, contractors, merchants and service groups for the following assistance: 1) endorsement and financial sponsorship; 2) land on which to build a park; 3) materials and construction. Members are prepared to offer their time and energy in return, where appropriate, as well as tangible recognition to organizations which support the effort. (Specifications for the park and clay models are also available.) Proceeds from fund raising events and sponsorship will go toward capitalizing 1) skateboard park construction; 2) equipment; 3) insurance; 4) maintenance; 5) monitoring and management. (Once the park is established, fees from users will cover the ongoing cost of operation.) The Association anticipates assuming responsibility for helping to manage the park.

There is precedent nationally for both private and public parks. Our main concern is that the association of teenage skateboarders have an opportunity to help develop the park and help run it when built, regardless of whether it is a public or privately owned facility. We believe that a community which desires responsible behavior from its teenagers needs to allow their young people to assume responsibility rather than simply to show up at the gates to a skateboard park with entrance fee in hand.

Members of the associations are available to make presentations to interested parties on request. For further information, leave a message for Sherman B. Chickering at Youth Self Help 916/(265-5828). Youth Self Help is the facilitation agency for the skateboard associations.

## SOUTH AFRICA

We of the above Association, have been working very hard trying to get things moving in South Africa. We have held about 15 contests in the past, including two South African Championships, all of which went down very well even though we have no track in South Africa suitable for a contest. We are trying to get an International together on the 16 & 17 July 1977. We will appreciate your help. All of these contests are offering prize money in the thousands. We have already collected 1 000 Rands for the Power Tracks Skateboard contest and hope to have a total of 3 000 Rands on the day of the contest.

Please try and get a couple of your Hotties interested. We will supply accommodation and transport; all they need is some cash for food.

We will pick them up at the Airport and organise everything this end. We are also trying to get a team together to come to the World Contest this year. If it is possible, could you please try and organise accommodation and transport for us; we hope to have a team of 10.

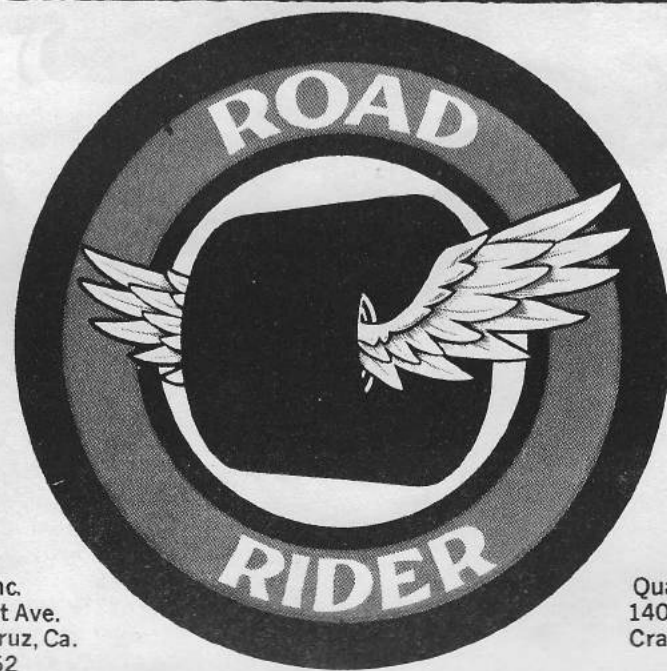

## "MADMAN" CONTEST Well Planned

Madman Skateboard Company in conjunction with a co-sponsor will be conducting a Pro-Am Slalom Skateboarding Contest. The contest is to be held July 16, 17 on the Palos Verdes Peninsula, California.

The total prize money to be awarded is \$1,000. This will be divided among those top five winners competing in the professional division. Those competing as amateurs shall receive valuable skateboard prizes. Again, these prizes will be divided among those ranking in the top five. The professionals shall be competing by invitation only, approximately twenty shall be invited. The amateur division is opened to the first 150 applicants.

There will be divisions for Womens Professionals and Womens Amateurs and divisions for Mens Professionals and Mens Amateurs.

Mr. Russell Wayne Howell will be the Emcee for the competition.

This event is being sanctioned by the Professional Skateboard Association (P.S.A.), Mr. Don E. Branker, president. Mr. Branker is highly involved in the event and will handle the selection of the professionals to be invited.

There will be opportunities for companies, skateboard and others, to man a booth in which they can display their products. These booths will be located in the close vicinity of the actual competition. Having such a booth would assist the companies with their business, as there is an estimated crowd attendance of 3,000.

A program is already in the process of being constructed, it will consist of:

1. A small write up and photograph of each professional competing.
2. A list of all the amateurs competing, their name, age, and the city they live in.
3. A calendar of upcoming skateboard events.
4. Skateboarding information such as: tips, skateboard parks etc.
5. There will be advertising by many different proprietors (companies)

There is still space available for advertising.

There will be a \$1.00 general admission fee along with concessions stands available for the general public. A special area will be roped off for those riders participating in the contest with free food and drink available.

The contest will be held on the Palos Verdes Peninsula on Crestridge Road which lies between Crenshaw and Hingridge. There is plenty of parking space available. Madmans has already obtained a one million dollar Insurance Bond with a Hold Harmless Clause. Madmans also has a full support from the city of Rancho Palos Verdes and the Los Angeles County Sheriffs Department.

The area chosen is a perfect one for such a contest as you see in the making here.

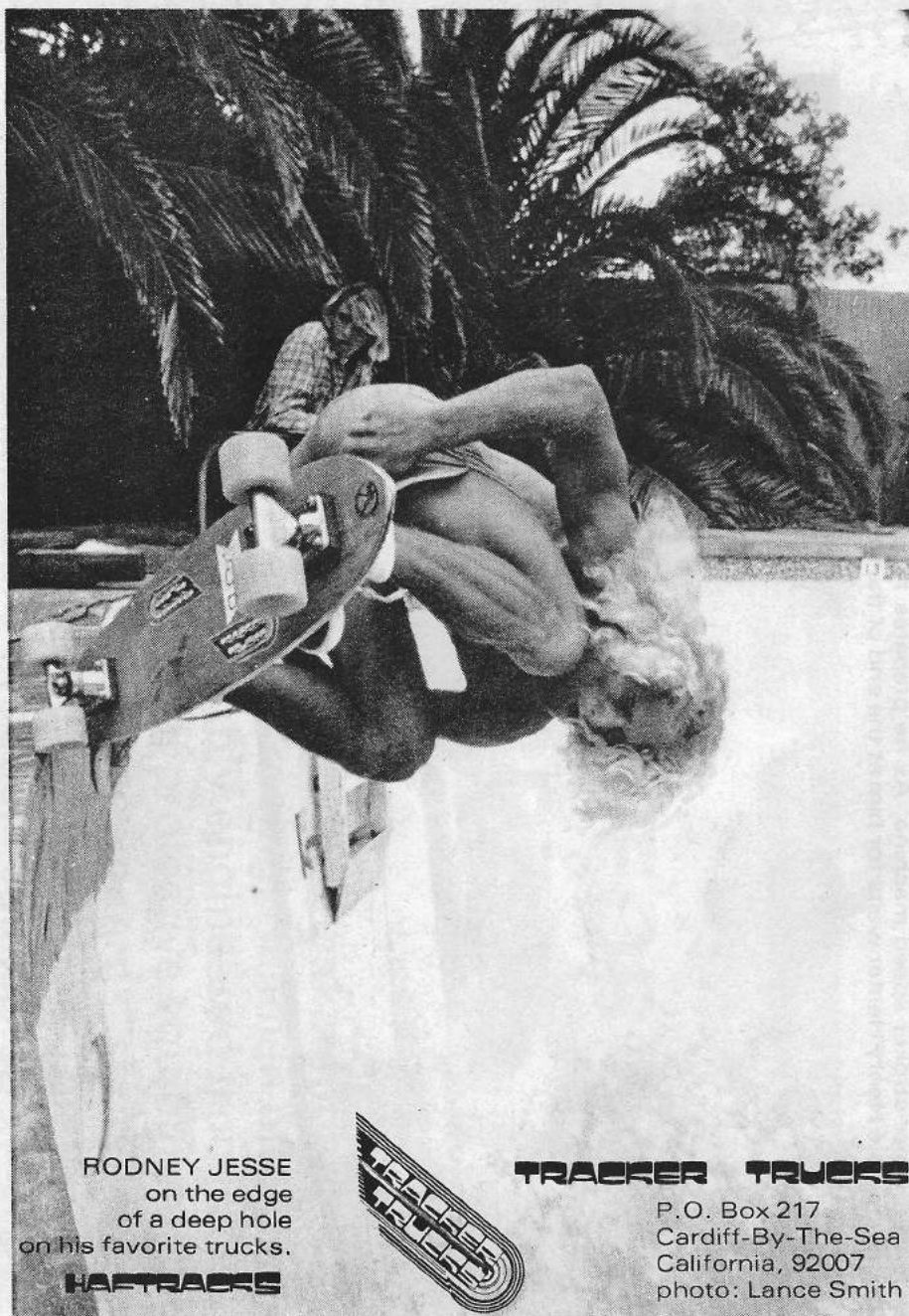

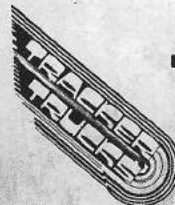
